A motion was made by Trustee Freelove, seconded by Trustee Gray to set the third Wednesday of each month at 7:00 pm as the date and time of the monthly Village Board meetings, all monthly meetings will be held in the CDC building 71 Maple Avenue in the Village of Cohocton unless otherwise specified. The motion carried 5-0.

The following motion was made Trustee McCarthy, seconded by Trustee Martin:

WHEREAS The Board of Trustees has determined to authorize payment in advance of audit of claims for: public utility services, postage, freight and express charges, insurances, Village association meetings, water training schools, Staples, Verizon and municipal workshops and training.

WHEREAS all such claims shall be presented at the next regular meeting for audit, and

WHEREAS the claimant and officer incurring or approving the same shall be jointly and severally liable for any amount disallowed by the Board of Trustees.

The motion carried 5-0.
