Tips to Avoid Becoming the Victim of a Scam

Recognize the "red flags" of a scam:

- 1. You didn't initiate the communication.
- 2. You are made to feel excited alarmed, scared, or panicked.



- 3. You are asked to provide payment through online transfers, gift cards, or reloadable money cards. Don't send money to strangers, to sellers who Insist on using the using the methods above for payment, or to anyone who claims to be a relative or friend in an emergency and wants to keep the request a secret.
- 4. Be wary of anyone asking for payment in gift cards.
- 5. If you are contacted by a known company and asked to provide any form of payment or personal information, discontinue the contact, and call the company yourself.
- 6. Do not use the contact information provided by the caller.
- 7. With internet phone services, it is difficult to tell where a call is coming from. It is a good idea to search online for the company name, website, and phone number.
- 8. Do not send money or give out personal information unless you initiated the call.
- 9. Government agencies such as the IRS will not contact you and/or accept payment by phone to pay fines, fees, taxes etc.
- 10. If you are informed via phone or email that you have an arrest warrant, it is probably a scam. Law enforcement will not contact you to demand money for violations you may have committed.
- 11. Some scams involve an email or text message from a bank or other institution. Computer repair scams can be used to access your personal information. If you think there may be a problem with your computer, that you can't fix, take it to a trusted, local repair business. Don't allow anyone to access your computer remotely.
- 12. If someone offers to pay more than they owe you, with the request that you send a portion to someone else, it is probably a scam.
- 13. If someone tells you that you have to pay to receive money you have won or been awarded, it is probably a scam



If you think you may be the victim of a scam please call your local police department.

Social Security COLA increase

There will be an 5.9% cost of living increase for social Security beneficiaries beginning in January 2022. The cost of living increase was based upon the consumer price index as determined by the Department of Labor Bureau of Labor statistics. Notices regarding changes in benefits will be received in early December.

Illinois Rental Assistance

The application window for rental assistance has been changed. It is now from December 6, 2021 to January 9, 2022. This was due to a switch with the application portal. You can apply through an IDHS provider agency. You can find a list of provider agencies, help with utility assistance, legal aid and other services at www.illinoisrentalassistance.org. Tenants can apply for up to 12 months of past due rent and up to three months of future rent payments. As of now, there is no date set for assistance with Mortgage payments.

Assistive Technology Funds Available

In collaboration with the Iowa Department of Aging, Easterseals Iowa is offering Iowans funding to obtain assistive technology.

- -funds are available to obtain assistive technology for Iowan with disabilities over the age of 18 or Iowans over the age of 60
- -the assistive technology must help an individual to increase their independence in activities of daily living, remain in their home, and/or have access to the community
- -the assistive technology remains the property of Easterseals but can be used as long as a person needs the device
- -an application is required
- -there is a \$750 limit per person
- -funds are limited and are on a first come first serve basis
- -Easterseals team members are available to assist with identifying assistive technology solutions

The project is funded through COVID19 Coronavirus Relief Funds and monitored by the Iowa Department of Aging.
