Standard Hours are Monday - Friday, from 8:30am - 3:00pm.



TUITION FOR 12-MONTH PROGRAM

Standard Tuition for Infant Care	3 to 15 months	\$2185 per month for 12 months.
Standard Tuition for Toddler Care	16 to 34 months	\$1685 per month for 12 months.
Standard Tuition for Primary Care	3 to 6 years	\$1375 per month for 12 months.
Extended Morning Care (7:30am - 8:30am)	Infant/Toddler Primary	\$175 additional per month \$150 additional per month
Extended After Care (3:00pm - 6:00pm)	Toddler Primary	\$450 additional per month \$375 additional per month

FEES

Application / Enrollment Fees

There is no fee to submit an application. **There is a one-time, non-refundable Enrollment Fee of \$350 that will be due within 2 weeks after acceptance into a program to hold a child's spot in the program.**

There are no Building, Material, or Snack Fees added to your annual tuition. All materials, snacks, lunches, and weekly music program are included in tuition.

Late Fees

Tuition payment is due in advance or on the 1st of each month. **There is a late fee of \$75 added to payment received after the third of the month.** There is a \$35.00 charge for returned checks.

Absences Due to Vacations, Holidays, Illnesses

There are no deductions for vacations, holidays, or illness. The Winter, Spring, and Summer Breaks are included in the 12-month tuition.

Tuition Discounts:

There is a 10% sibling tuition discount for the second child from the family. Discount applies to the Standard Hour tuition rates; it does not include Extended Care rates.

COVID-19 & Weather-Related Closures

Little Village Montessori is a licensed childcare center in the state of Oregon. Due to the COVID-19 Pandemic, LVM is mandated to follow the rules and regulations set forth by the Oregon Department of Early Learning and Care, a division of the Oregon Education Department. Policies regarding quarantining are subject to change throughout the year, per the ELC and OHA recommendations.

A long-term closure (longer than 15 days) could occur if the state or county sees a surge in COVID-19 cases and the state of Oregon mandates school and childcare closures OR the state or county sees a surge in COVID-19 cases and LVM decides that it must move to distance learning for the safety of our staff and families.

All families will receive access to:

- Distance learning support plan and weekly/daily schedule
- Distance learning appropriate for the developmental age group
- Google Classroom to access content and communicate with your classroom guide
- Weekly Classroom Zoom gathering and/or Weekly Guide check-in via Zoom

We follow the Portland Public School's announcements of weather-related school closures and delays. Tuition is not refunded for school closures due to power outages, inclement weather, holiday, or multiple staff illnesses that require a class to close.

For any such closure shorter than 15 consecutive days in a month, there will be no reduction in tuition for that month. For closure conditions longer than 15 days in any month, the school will charge up to 50% tuition for the duration of the closure in that month and will charge 100% tuition for any duration that the school is open. This clause allows the school to retain at least key staff on payroll, readily available to return to the classroom to welcome our children back when the school reopens. Distance learning will be offered for closures longer than 15 days.

Withdrawal:

Little Village Montessori requires **two months** written notification prior to the withdrawal of a student from school. Failure to receive written notification will result in tuition charges for that period.
