

**Town of Stratton  
Selectmen's Meeting**

**October 9, 2017**

**Present:** Selectmen: Chair - Al Dupell, Larry Bills, Chris Liller, Greg Marcucci and Kevin Robinson; and Clerk – Kent Young.

Al Dupell called the meeting to order at 7:30pm. Orders were reviewed and signed.

**Modifications:** No modifications were made.

**Road Crew Issues: Culverts:** Chris Liller reported that the Stratton-Arlington Rd. culvert installations have been completed. It appears that patch paving over the culverts will begin this week. **County Rd. repairs:** Larry Bills said that the Road Foreman should get the 15' fabric and that the project can be done this fall. **Security Systems:** The fire and burglar alarm systems have been completed for the garage. Al Dupell signed the monitoring agreement. The Chair also verified contact information. The Selectmen agreed to have a siren installed at the garage as well. **Kelley Stand Parking Lot:** The aprons on the Kelley Stand lot entrance and exit have been paved as promised by the National Forest. **Town Roads used by Snowmobiles:** Chris Liller moved to continue to keep open the following roads for use by snowmobiles this winter – 1) Stratton-Arlington Rd. from Grout Pond Rd. to the Sunderland town line, 2) Grout Pond Rd., 3) Canedy Rd., 4) Ball Farm Rd., 5) Old Town Rd. and 6) Shepardson Rd. Larry Bills seconded – all concurred.

**Rec. Area:** Larry Bills stated that preparations for, and installation of the power line can begin soon. There was no discussion concerning the pavilion.

**Town Hall Requests:** Jackie Bedard for Oct 22/23 for the Francis Capen memorial fundraiser; Nancy Rigoulot for Oct 27 for preparations for the Gilfeather Turnip festival; Candie Bernard for Nov 4 for the Coburn's 50<sup>th</sup> anniversary; Candie Bernard for Nov 18; the Wardsboro Snowmobile Club for December 2; the Selectmen agreed to have the Town's Holiday Party on December 9. Chris Liller moved to approve all requests. Kevin Robinson seconded – all concurred.

**Minutes:** Greg Marcucci moved to approve the Selectmen's Minutes of September 25, 2017. Chris Liller seconded the motion. All concurred and the minutes were approved.

**Other Business: Town Attorney:** Kent Young requested permission to discuss the ongoing Landmark issue with the Town Attorney – The Selectmen concurred.

**Adjourn:** Chris Liller motioned to adjourn at 8:25p.m.. Kevin Robinson seconded. All were in favor and the meeting adjourned.
