**BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 4  
RESOLUTION FOR THE 2025 TAX RATE**

WHEREAS, the Bexar County Emergency Services District No. 4 desires to adopt a tax rate for the year 2025; and,

IT IS THEREFORE RESOLVED, Bexar County Emergency Services District No. 4 has adopted a tax rate of \$0.064607 for each \$100.00 of taxable value which is effectively 12.94 percent increase in the tax rate.

FURTHER RESOLVED, THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE; AND,

FURTHER RESOLVED, THE TAX RATE WILL EFFECTIVELY BE RAISED BY 15.65 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000.00 HOME BY APPROXIMATELY \$7.40.

This total tax rate shall be levied as follows:

There shall be levied and collected upon all taxable property in Bexar County Emergency Services District No. 4 for the year 2025, for the use of the Bexar County Emergency Services District No. 4, an ad valorem tax for maintenance and operations of \$0.0646 on each \$100 of taxable property so assessed to be credited to the General Fund of Bexar County Emergency Service District No. 4.

There shall be levied and collected upon all taxable property in Bexar County Emergency Services District No. 4 for the year 2025, for the use of the Bexar County Emergency Services District No. 4, an ad valorem interest and sinking of \$0.0 on each \$100 of taxable property so assessed to be credited to the Debt Fund of Bexar County Emergency Services District No. 4.<sup>§</sup>
