## TOWN OF PREECEVILLE BYLAW NO. 4 – 2020

# A BYLAW TO ESTABLISH GENERAL ELECTION PROCEDURES

The Council of the Town of Preeceville in the Province of Saskatchewan under the provisions of Section 9.1 of the Local Government Election Act, enacts as follows:

- 1. All candidates must include their occupation on the nomination paper and the candidate's occupation will be printed on the ballot as it appears on the nomination paper.
- 2. The following provisions must govern the form of ballots:
  - a) ballots must be printed in as many lots as there are candidates for the office;
  - b) in the first lot, the names of the candidates must appear, in alphabetical order of their surnames and in the case of two or more candidates having the same surname, in alphabetical order of the initial of their given names;
  - in the second lot the names must appear in the same order as the first lot, except that the first name in the first lot must be placed last;
  - d) in each succeeding lot, the order must be the same as that of the preceding lot, except that the first name in the preceding lot must be placed last; and
  - e) tablets of ballots to be used at polling places must be made up by combining ballots from the different lots in regular rotation so that no two consecutive voters will receive ballots from the same lot, and so that each candidate's name will appear first and in each other position substantially the same number of times on the ballots used.
- 3. The following remuneration will be paid to election officials acting with respect to an election:
  - a) Returning Officer \$400.00:
  - b) Deputy Returning Officer \$350.00; and
  - c) Poll Clerk \$300.00
- The Polling Place shall be the Preeceville Community Legion Hall at 218 Main Street N.
- 5. This bylaw shall have application commencing with the General election to be held in 2020.
- 6. This bylaw shall come into force and take effect upon final passage thereof.
