STRATTON SCHOOL BOARD MINUTES
OCTOBER 11, 2012

The Stratton School Board held its regular monthly meeting on October 11, 2012 at the Stratton town office. The meeting was called to order at 7:30 P.M.

ATTENDING: John Mallard, Patti Siegel, Vince Schuch, Kristi MacDonald, Thomas Montemagni, Siobhan Eddy Young and Lorraine M. Weeks-Newell

The minutes of the September 13, 2012 were read and approved.

NEW BUSINESS:

Mrs. Kristi MacDonald attended the meeting to submit her residency information. Along with her Residency Policy, she provided a pay stub, lease agreement, drivers license and bank statement. Also included was her application for addition to the Stratton check list. With the exception of her voter application, all of the information showed a Bondville post office address. The Board will hold a decision pending documentation of a Stratton address and will address her application when she is added to the voter list in Stratton.

Mr. John Mallard also attended the meeting to submit his application to the Board. His daughter is a student at SMS. Included with his completed residency information, Mr. Mallard provided the Board with his bank statement, voter registration form & drivers license. Also included was a letter of residency from the homeowner who the Mallards are renting from. The Board reviewed his application and found it complete. The town office will contact Mr. Mallard to let him know of the Board's decision to provide tuition for his daughter.

Ms. Jill Adams Mancivalano came to the office to drop her signed transportation form.

CONTINUED BUSINESS:

Ms. Patricia Siegel attended to ask the reason for the Board's decision to deny tuition. Chairman Thomas Montemagni directed her to the Vt. Dept of Education to get the information she will need if she should decide to appeal the School Board's decision.

POLICY

The Board reviewed the tuition Payment Policy Code F16. Because the Board changed wording in the document and adopted final language, the policy will be posted and the Board will schedule a vote for final approval at the next scheduled meeting on November 8, 2012.
