After **December 15th**, booth allocation is on a first come first serve basis. New applicants will not know booth allocation or show acceptance until **after January 15th**. Upon acceptance into the show and full payment made, a Confirmation letter will be sent to you with your booth assignment and show guidelines. Booth assignment may be subject to change before the show.

### PAYMENT:

Full payment of fees and # 10 Self Addressed Stamped Envelope is required with application. **All fees are non-refundable after February 1st**. No exhibitor will be allocated booth space or allowed to move-in until payment has been made in full.

### EXHIBIT CONTENT AND MANNER OF USE:

**ALL CRAFTS MUST BE HAND MADE.** New exhibitors or exhibitors that change product(s) must supply pictures that prove all products are hand made. **THE BIG ONE** reserves the right to make decisions relative to the show content and reserves the right to reject exhibits which it deems unsuitable to the show or for any reason we see fit.

### SALES TAX:
