

# **Bloomfield Police Department**

## **Monthly Report for January 2017**

This is the monthly report for the Month of January 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, January 1<sup>st</sup> at approximately 11:30am officers responded to a residence on Hwy H for a disorderly conduct complaint. At the conclusion of the investigation a 23-year-old male subject was issued a non-traffic citation for disorderly conduct.

On Tuesday, January 3<sup>rd</sup> at approximately 10:15am officers responded to the area of Cherry St. and Forest Road for a theft complaint. It was reported that two subjects attempted to flee from a taxi cab without paying the fare. The taxi cab driver reported that he fired a single shot from his handgun in an attempt to stop the fleeing patrons. At the conclusion of the investigation charges of disorderly conduct while armed were forwarded to the Walworth County District Attorney's office for the 24-year-old cab driver. Charges of theft were forwarded to the Walworth County District Attorney's office for a 17-year-old female and a 17-year-old male.

On Tuesday, January 3<sup>rd</sup> at approximately 12:59pm officers received a theft complaint. At the conclusion of the investigation a 23-year-old female was issued a non-traffic citation for a municipal ordinance violation.

On Tuesday, January 3<sup>rd</sup> at approximately 5:58pm officers received a burglary complaint which occurred on Celadine Road. At the conclusion of the investigation charges of burglary and theft have been forwarded to the Walworth County District Attorney's office for a 20-year-old male and a 17-year-old male. Numerous items taken during the burglary have been recovered.

On Wednesday, January 4<sup>th</sup> at approximately 12:20am officers stopped to check the welfare of a motorist on Pell Lake Drive at the Hwy 12 overpass after observing the vehicle stopped on the shoulder of the road. Officers spoke with and subsequently arrested the 31-year-old driver after learning that he was intoxicated. The driver was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense.

On Thursday, January 5<sup>th</sup> at approximately 7:10am officers received a theft complaint which had occurred at the Pell Lake Mobil. At the conclusion of the investigation a 40-year-old female was arrested and confined in the Walworth County Jail. Charges of theft and felony bail jumping have been forwarded to the Walworth County District Attorney's office.

On Wednesday, January 11<sup>th</sup> at approximately 7:00am officers responded to Olson's Starter Service on Post Road for a burglary complaint. Information surrounding this incident has been intentionally withheld as this is an active investigation.

On Thursday, January 12<sup>th</sup> at approximately 2:35pm officers responded to Geneva Auto Sales on Hwy H for a theft of a motor vehicle complaint. Officers responded to the business where the necessary information was obtained for the vehicle to be entered as stolen. As of this date the vehicle has not been located or returned and remains entered as stolen.

On Friday, January 20<sup>th</sup> at approximately 7:22am officers responded to a report of a property damage only crash on Hwy H in the area of White Pigeon Road. Upon arrival officers learned the vehicle had been abandoned after the crash. At the conclusion of the investigation a 41-year-old male was issued uniform traffic citations for inattentive driving and failure to notify police of an accident.

On Saturday, January 21<sup>st</sup> at approximately 12:51am officers responded to a report of a single vehicle crash on Hwy U in the area of Center Drive. At the conclusion of the investigation a 52-year-old male was arrested for operating a motor vehicle while intoxicated and ultimately confined in the Walworth County Jail. Charges of deviation from designated lane and operating a motor vehicle while intoxicated 4<sup>th</sup> offense have been forwarded to the Walworth County District Attorney's office.

During the month of January 2017 the Bloomfield Police Department responded to 733 calls for service compared to 1,068 calls for service during the month of January 2016. During the month of January 2017 the police department affected 86 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 111 arrests during the month of January 2016.
