<u>Discussion and approval of hiring additional operator</u> The committee recommends hiring at least one operator to support the increasing workload and to get more preventative maintenance accomplished. Tom is doing very well, and he and Kenny make a good leadership team. Dana recommended hiring two operators right away, pending budget review, as there is continued growth in the area and with the SVWID project coming two extra operators will be needed. The board discussed the budget amendment likely needed for a future meeting date. Motion by Dale Weiss to hire two additional operators. Second by Ken Helfenbein. MOTION CARRIED 10-0.

<u>Lake/Snow report – irrigation update</u> the lake is at 476 AF, SWE is 0% of average and Precipitation is 54% of average. Soil moisture is at 9%. Letters went out to all irrigation customers informing them of the lake levels and what the staff has been doing to get the wells situated. A variable frequency drive (VFD) is needed for the Beeman well and a pressure switch needs to be purchased for the Corbin well. The big irrigators are helping and willing to do what they can to help the situation. Dana will provide irrigators with an approximate number for overage costs. NWS is predicting rain throughout the next 5 days.

<u>Items from staff</u> Dana has been working on an agreement with San Juan County for sewer collection. The board meeting for next week is still undecided and the board feels comfortable enough to let staff decide the numbers for the irrigation customers.
