## **Discussion Topics**:

- <u>Board Meeting Rules</u> Jon Testut pointed out that the expectation is that all Trustees attend all monthly Board Meetings. Regarding "Visitor Comments/Presentations", there was some discussion as to having Visitor Comments at the beginning of the board meetings instead of at the end. This was tabled for further consideration.
- <u>Board Meeting Agendas</u>: Jon requested that trustees provide topics for discussion in a timely manner so the Office can prepare the Tentative Agenda for posting on the LBVCA website one week before a board meeting.
- <u>Purpose of Office Administrator Position</u>: Jon will route a copy of the Office Administrator's Duties & Responsibilities list to all Board members so they understand the demands on the Office. Marty asked that Trustees refrain from asking Marty to be their personal secretary as that is not the purpose of the Office Administrator.
- <u>Communication via phone, email, texting</u>: Marty will email all Trustees with an updated "Trustee Contact Information" sheet.
