- 1. Roll call: Selectman Dan Chamberlain, Selectman Melissa Patterson, & Selectman Robin Cyr present.
- 2. Secretary's Report: Mrs. Patterson motioned to accept the May 8, 2017 & May 22, 2017 minutes as written, Ms. Cyr seconded, all voted in favor.
- 3. Citizens' Concerns:

*Charlie Kent-* Mr. Kent requested a copy of a check made payable to Mr. Kent from the Town of Benton from March 2014. This request was provided to Mr. Kent thru the office staff. Mr. Kent claims this is the first time he's seen the check. He claims he did not cash and or sign the check. Audrey Lee claims to see "hinkey stuff "going on with Mr. Kent's check image from the bank. Documents from March 2014 are attached to show this was resolved on March 18, 2014. *Audrey Lee-* Mrs. Lee wants to know about the May 22<sup>nd</sup> Selectmen meeting. Mr. Chamberlain informed Mrs. Lee that the Town of Benton signed a contract for the new Benton CEO.
