1.0 PURPOSE:

To provide guidelines for Cumberland Road Fire Department personnel who have encountered an incident where forcible entry into a structure or vehicle may be necessary.

2.0 PROCEDURE:

- Structure: Residential, Commercial, or Out Building(s)
 - An incident presents as an emergency situation or condition where access to structure is necessary to mitigate the situation.
 - o Situation examples may include but not limited to:
 - Confirmed life hazard with a working fire.
 - Invalid or patient unable to exit structure under self-power with visual and/or verbal contact of patient verifying same
 - Infant or child, invalid patient, and/or bed-confined patient who is noted as being locked in residence with access by normal means not achievable.
 - Visual confirmation of smoke inside of structure with access by normal means not achievable
 - Personnel will verify that access by normal means such as an unlocked door or window in which access may be gained, key availability from the occupant, property owner, Knoxbox, neighbor, and/or other representative associated with the property is not achievable.
 - Personnel, upon determining forced entry is necessary, will request a
 representative from Law Enforcement having jurisdiction to respond to the scene.
 If non-life threatening, personnel are encouraged to delay forced entry until the
 arrival of a Law Enforcement representative. If the situation is life-threatening,
 personnel may proceed with forced entry before the Law Enforcement
 representative's arrival.
 - O If possible, personnel will have the property owner or occupant sign the Cumberland Road Fire Department Forced Entry Release Form. Incident where a life hazard is confirmed or life safety is noted, deviation from completing the release form is permissible. The reason for the deviation is to be documented within the incident report.
 - Personnel shall select the most appropriate tools and equipment to perform forcible entry tasks, operating in a manner to do the least amount of possible damage to the property.
 - The Company Officer will ensure accurate completion of paperwork and ensure all paperwork is attached to report upon entry into Firehouse Reporting Software.

- Vehicle (Personal/private, Public, Commercial)
 - An incident presents as an emergency situation or condition where entry into the vehicle is necessary to mitigate the situation.
 - o Situation examples may include but not limited to:
 - A person locked in a vehicle and is unable to unlock or provide assistance in unlocking the vehicle to gain access with weather conditions noted as extremely high temperatures or extremely low temperatures.
 - Animal locked in a vehicle with weather conditions noted as extremely high temperatures or extremely low temperatures.
 - Prescribed medications locked within the vehicle deemed lifesaving or use by fire personnel for patient care may be lifesaving for patients.
 Example(s) may be Epinephrine or Nitroglycerine (Nitro).
 - Before forcing entry, personnel will verify access to the vehicle by normal means such as an unlocked door or key is not achievable. Personnel should question the property owner to ensure access to the secondary key is not available.
 - O Personnel will have the vehicle owner or occupant, if possible, sign the Cumberland Road Fire Department Vehicle Forced Entry Release Form. An incident where a life hazard is confirmed or a life safety concern is noted, deviation from completing the release form is permissible. The reason for the deviation is to be documented within the incident report.
 - Personnel shall select the most appropriate tools and equipment to perform forcible entry tasks, operating in a manner to do the least amount of possible damage to the vehicle.
 - The Company Officer will ensure accurate completion of paperwork and ensure all paperwork is attached to report upon entry into Firehouse Reporting Software
