**Model Series: Grow Lights**

Lyra Lights warrants its Grow Lights to be free from defects in materials and workmanship for three (3) years from the date of original purchase, subject to limitations set forth herein ("Limited Warranty"). This Limited Warranty applies only to the original retail purchaser when this instrument is purchased from an Authorized Lyra Lights Dealer or Distributor and is subject to the limitations set forth herein.

**IMPORTANT: PLEASE RETAIN YOUR ORIGINAL SALES RECEIPT, AS IT IS YOUR PROOF OF PURCHASE VALIDATING THIS LIMITED WARRANTY.**

Lyra Lights has established a network of Authorized independent Dealers and Distributors for technical support and or warranty service. The Lyra Lights Dealer or Distributor from whom you purchased your Grow Lights may also be authorized for warranty service and should be the first point of contact when service of any kind is required for your Grow Lights. To receive warranty service, return the entire Grow Light (everything that came in the box) to an Authorized Dealer or Distributor, with your sales receipt as proof of purchase, during the applicable Limited Warranty period. To the extent feasible, defective components that qualify for coverage under this Limited Warranty may be repaired or replaced at Lyra Light's discretion without charge. If the qualified component is not repaired, Lyra Lights may, at its sole discretion, either replace with a comparable product. Remedies beyond normal service repair of any Lyra Lights product require both an evaluation and confirmation of the defect and a direct recommendation to Lyra Lights for alternative considerations.

All transportation, insurance and freight charges associated with warranty service and or repairs on Lyra Light Lights products are the responsibility of the purchaser, as is any service initiated for the purpose of customizing setups or adjustments beyond factory specifications. If required, initial standard setup and or adjustment of the product and its components at the time of purchase are considered normal Dealer or Distributor product preparation and are not covered by this Limited Warranty.

### Limitations and Exclusions:

The following items are **not** covered by this Limited Warranty.

1. Water damage, moisture damage, or any other type of foreign material damage (either inside or outside the unit).
2. Scratches, dents and or discoloration of any kind, missing of: nuts/bolts, brackets, cables,
3. Setups, adjustments or routine maintenance of any kind.
4. Damage to finishes or cracks, splitting, or warpage of any kind due to changes in temperature or humidity, exposure to or contact with sun, fire, moisture, any other chemicals or non-Lyra Lights-approved materials.
5. Damage, corrosion or rusting of any hardware components caused by humidity, salty air, or exposure to the moisture.
6. Any damage to product resulting from customization or modification.
7. Normal wear and tear on any part of the product, including controls, switches, plated/painted surfaces, mechanical case hardware etc.
8. All other damage and deterioration due to normal usage, wear and tear, aging, accidents, neglect, abuse, and or Acts of Nature.
9. Any product, whose serial number is missing or any affixed label on product is, altered or tampered with in any fashion.
10. Any product purchased from anyone other than an Authorized Lyra Lights Dealer or Distributor.
11. Instruments that have been serviced by unauthorized persons (any person other than a Lyra Lights Certified Technician at a Lyra Lights Service Location).
12. Inadequate and or improper power supplied to the product. AC line power supply must conform to all local, state, and federal regulations.
