The meeting was called to order at 6:05 PM CT with President Eubanks, with a quorum of officers and members of good standing in attendance. Following the invocation by Compatriot Shows, Pledges of Allegiance were rendered to the Flags of the United States and SAR followed by recitation of the American Creed.
