B. Counterman discussed parent shirts and jersey orders for players. Parents are able to order a matching parent shirt to their player through registration on Sports Engine. She is currently structuring the rules and guidelines for flag football to improve playing time. Counterman has been working on the parent code of conduct contract. To be emailed to parks for review. The liability waiver is to be turned into Sara for review by City Attorney.

Moving forward with tackle football cheer will look at restructuring the cheer teams where kids cheer for their own grade of football players. If unable to get enough girls per grade possibly consider combining 3/4th grade and 5/6th grade. Possibly have the parkboard members have the opportunity to interview parents interested in volunteering to coach.
