PRESIDENTIAL PREFERENCE & MEIGS COUNTY PRIMARY ELECTION

During the **Early Voting** period (**February 12th -February 25th, 2020**) you will be able to vote in person for the **March 3, 2020 Election** at the following locations:

Voting hours will be February 12th through February 25th, 2020

9:00 a.m.-12:00 Noon Monday – Saturday

*Early voters should be prepared to show Federal or Tennessee State issued Photo ID to vote (TCA § 2-7-112)

*Voters whose polling place is not assessable to the elderly or handicapped may also vote early during this period.

*Any voter that registered by mail and has never voted must vote in person the first election after their registration.

ABSENTEE VOTING BY MAIL (TCA § 2-6-202) (a)(3)

A person who wishes to vote **absentee by mail** and meets the qualifications may **obtain an application in person, by fax, email (with a scanned signature) or by mail at the Meigs County Election Commission Office**. To inquire about the qualifications, contact the Meigs County Election Commission Office at (423) 334-5866 or e-mail: meigscoelect@gmail.com. Absentee applications must be completed in full and returned no later than February 25, 2020. The voter's **absentee ballot must be received by mail** no later than 8:00 P.M. March 3, 2020 at the Meigs County Election Commission to be eligible to be counted.

Last day to register to vote for this election is February 3, 2020

Photo ID Requirements for All Voters

(TCA § 2-7-112 (a) (1)) Tennessee State Law requires all voters voting in person to present a Federal or a State of Tennessee issued photo ID. The ID must contain the voter's name and photograph.
