

TOWN OF MARBLE
ORDINANCE TO SET MILL LEVIES

AN ORDINANCE LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 1993, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF MARBLE, COLORADO, FOR THE 1993 BUDGET YEAR AND DECLARING AN EMERGENCY.

WHEREAS, the Board of Trustees of the Town of Marble has adopted the annual budget in accordance with Local Government Law, on November 4, 1992 and;

WHEREAS, the amount of money necessary to balance the budget for general operating expenses is \$6,754, and;

WHEREAS, the amount of money necessary to balance the budget for Streets & Bridges is \$0, and;

WHEREAS, the amount of money necessary to balance the budget for Park expenditures is \$ 0, and;

WHEREAS, the 1993 valuation for assessment for the Town of Marble as certified by the County Assessor is \$910,300.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES of the TOWN OF MARBLE, COLORADO:

Section 1. That the purpose of meeting all general operating expenses of the Town of Marble during the 1993 budget year, there is hereby levied a tax of 7.420 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Marble for the year 1993.

Section 2. That for the purpose of meeting all bonds and interest of the Town of Marble during the 1993 budget year, there is hereby levied a tax of 0 mills upon each dollar of total valuation for assessment of all taxable property within the Town of Marble for the year 1993.

Section 3. That for the purpose of meeting all the Division of Local Government approved capital expenditures of the Town of Marble during the 1993 budget year, there is hereby levied a tax of 0 mills when each dollar of the total valuation for assessment of all taxable property within the Town of Marble for the year 1993.


ORDINANCE TO SET MILL LEVIES - Continued

Section 4. That the Town Clerk is hereby authorized and directed to immediately certify to the County Commissioners of Gunnison County, Colorado, the mill levy for the Town of Marble as herein above determined and set.


Section 5. The Board of Trustees hereby finds and declares that an emergency exists, and that that the passage of this ordinance with an effective date upon passage is necessary to the immediate preservation of the public peace, health, and safety of the Town of Marble and its citizens, because the revenue provided for in the Town's 1993 budget is necessary for the Town's peace, health and safety.

Section 6. This ordinance is effective upon passage by three-fourths of all members of the Board of Trustees.

ADOPTED, this fourth day of November, A.D. 1992 by a vote of 4 to 0 with one absent.
