

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to the <http://www.californiahomeschoolsports.com/> and California Home School Sports and governs data collection and usage. ### **Collection of your Personal Information**

CHSS may collect personally identifiable information, such as your name. If you purchase CHSS's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by CHSS.
