COLORADO: Currently accepting 2014 annual filing statements. All surplus line producers are required to file annual statements electronically by March 1, 2015, and payment of any tax owed must be received by March 1, 2015, to avoid a penalty. Even if you are reporting zero filings for the entire year, you are still required to electronically file an Annual Statement. Please make sure all policies are reported for the year before filing your Annual Statement including return premium or cancellations.
