- 11. To develop a list of prospective appointees of public officials, consider applications, and make one (1) initial exclusion of prospective appointees from further consideration. [I.C. § 5-14-1.5-6.1(b)(10).]
- 12. To discuss information and intelligence intended to prevent, mitigate, or respond to the threat of terrorism. [I.C. § 5-14-1.5-6.1(b)(13).]
