## Ordinance No, 748

An ordinance levying a corporate tax on property in the city of Garnett, Kansas. Special Sewer assessments and Paving assessments for the city of Garnett, Kansas, for the fiscal year ending June 30, 1919.

Be it ordained and enacted by the Mayor and Commissioners of the city of Garnett, Kansas,

Section Two: - that a corporate tax be and the same is hereby levied an all the taxible property in the city of Garnett, Kansas, for Street and alley purposes 10- Centre on each one hundred- Dollars valuation.

Section Three: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Garnett, Kansas, for water Works fund 10-cents on each one hundred-Dollars valuation.

Section Four: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Garnett, Kansas, for Electric Light fund 10 each on each onehundred - Dollars voluation.

Section Five: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Garnett, Kansas, for Fire Fund 4-cents on each one hundred-Dollars valuation.

Section Six: - that a corporate tax be and the sam is hereby levied on all taxible property in the city of Garnett, Kansas, for library fund on each one hundred-Dollars valuation.

Section Seven: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Carnett, Kansas, for water works extension Bond sinking fund, Section on each one hundred-Dollars valuation.

Section Eight: - that a corporate tax be and the same is hereby levied an all taxible property in the city of Garnett, Kansas, for water works extension bond interest fund, 6 - centre on each one hundred-Dollars valuation.

Section Nine: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Garnett, Kansas, for water works extension bond sinking fund, 1913, 2 - cuts on each one hundred-Dollars valuation.

Section Ten: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Garnett, Kansas, for water works extension bond interest fund, 1913, 2 - cents on each one hundred - Dollars valuation.

Section Eleven: - that a corporate tax be and the same is bereby levied on all taxible property in the city of Garnett, Kansas, for water works improvement bond sinking fund 2/2 cents on each one hundred-Dollars valuation.

Section Ewelve: that a corporate tax be and the sme is hereby Levied on all taxible property in the city of Garnett, Kansas, for water works Improvement bond interest fund 4/2 cents on each one hundred-Dollars valuation.

Section Thirteen: - that a corporate tax be and the same is hereby levied on all the taxible property in the city of Garnett. Kansas, for Electric Light Bond Sinking fund 2 - cents on each one hundred-Dollarsvaluation.

Section Fourteen: - that a corporate tax be and the same is hereby levied &nall taxible property in the city of Garnett, Kansas, for Electric Light Bond Interest fund \_\_\_\_\_\_ on each one hundred- Dollars. valuation.

Section Fifteen: - that a corporate tax be and the same is hereby levied on all taxible property in the city of Garnett, Kansas, for Main Sewer bond sinking fund, \_\_\_\_\_\_ on each one hundred-Dollars. Uplication

Section Sixteen: - that a corporate tax be and the same is hereby levied on all taxable property in the city of Garnett, Kansas, for main sewer Bond interest fund Security on each one hundred Dollars. Valuation

Section Seventeen: that a corporate tax be and the same is hereby levied on all taxable property in the city of Garnett, Kansas, for paving Intersectional bond fund 20 ents on each one hundred-Dollars valuation

Section Eighteen: - that a special assessment is hereby made on all lots and pieces of ground in sewer District No, (1) liable for sewer assessments for the purpose of paying one tenth of the original assessment and six per cent interest on Three tenths of the original assessment for one year.

Section Nineteen: - that a special assessment is hereby made on all lots and pieces of ground in sewer District No, (2) liable for sewer assessment to pay one tenth of the original assessment and six per cent interest on Three tenths of the original assessment for one year.

Section Twenty: - that a special assessment is hereby made on all lots and pieces of ground in sewer District No, (3) liable for sewer assessments and six per cent interest THIRE on three tenths of the original assessment for one year.

Section Twenty One: - that a special assessment is hereby made on all lots and pieces of ground in the paving District liable for special assessment for paving to pay one tenth of the original assessment and (4-3/4) Four and Three fourths per cent interest on nine tenths of the original assessment for one year except on Fourth Avenue between blocks 50 and 31- 49and 32-48 and 33-47 and 34-46 and 35 and on Fifth Avenue between blocks 46 and 55 - and on Oak street between blocks 46 and 47- on which a special assessment is hereby made to pay one tenth of the original assessment and (4-3/4) Four and Three Fourths per cent interest on Right tenths of the original assessment.

Section Twenty Two: - that a special assessment is hereby made on all lots and pieces of ground liable for paving assessment to pay one tenth of the original ssessment and (4-3/4) Four and Three Fourths per cent interest on on the original assessment on Oak street between blocks 34 and 35 - 26 and 27.

Section Twenty Three: - that a corporate tax be and the same is hereby levied on all taxable property in the city of Garnett, Kansas, for water and Light Improvement Bond Sinking Fund 1918- 5 - cents on each one hundred-Dollars valuation.

Section Twenty Four: - that a corporate tax be and the same is hereby levied on taxable property in the city of Garnett, Kansas, for water and Light Improvement bond interest fund 1918-Dollars valuation.

Section Twenty Four: - that this ordinance shall take effect and be in force from and after 10 days after its passage XNN by the Board of Commissioners and its approval by the Mayor and publication in the official paper.
