Clinton County Sheriff Report: A monthly email report was presented to the Board from Clerk Smith. It basically entailed the number of tickets that had been given out in Greenbush Township for the month .Also reported on are different instance's that happen in Greenbush. We are a well-protected community.

CAAS Report: Reported from their monthly meeting five (5) applications have been submitted for the Directors jobwhich is currently being held by Lynn Weber. Director Weber hopes to retire soon and would like to work with a new director for a few months before he leaves his position. The ambulance runs are up 100 from last year. At this time there are three (3) Ambulance riggs that are in good working condition.

Clinton Transit: Nalissa Schutt presented the annual report from Clinton Transit and gave Insite on all the transportation needs that are being taken care of. She highlighted the areas that the busses travel and the need for them to expand their services. The surrounding communities

have gotten great usage of this service and their Board is always looking to make improvements. Mellisa also wanted remind the Township that on the August 6th, 2024 ballot there will be a tax proposal for Clinton Transit which basically is just the same tax base but just a renewal. She again thanked the Township Board for their support and letting her speak at the meeting.

Special Meeting Minutes: The Special Meeting Minutes were read by Clerk Smith. This meeting was called by Supervisor Thelen so that a resolution could be signed for the wording of the Road Renewal that will be going on the August 6<sup>th,</sup> ballot. This Resolution needed to be forwarded to our Township lawyers to make sure the Township is in compliance with the County for proper wording. \* Motion by Kindel to accept the minutes as read. \* Seconded by Graham \*Motion passed

Reading and Approval of Prior Month's Minutes: March minutes were brought off the table to be approved by a\* Motion from Kindel and \*Seconded by Graham \*Motion passed. Minutes were approved and the reading was dispensed by a \*Motion from Graham \*Seconded by Kindel. A Motion was also made Kindel to accept the April minutes and to dispense with their reading. \*Seconded by Graham \*Motion passed.

## Treasurer's Report & Approval of Bill Payments:

Treasurer Roof gave the report by asking that the Profit and Loss and the Balance sheet of the previous month be approved and that checks # 14527-14544 plus ACH and EFTPS be approved for payment. \*Motion by Graham to accept the Treasurer's report as given and to pay said

checks along with ACH and EFTPS. \*Seconded by Smith\*Motion passed

Correspondence: Phil Hanses Clinton County Drain Commissioner was present to ask for support in his bid for re-election this August. Resident Owen again stressed how important it is to sign the Petition that will get County Zoning under its own control and not run by the local government. Hopefully to be on the August 6<sup>th</sup>, 2024 ballot. Clerk Smith reminded the Residents of the upcoming Memorial Day Services at the Eureka Cemetery, Monday May 27<sup>th</sup> 10am Public Comment: Resident Kellogg commented on Briggs District Library that the renovation is going a little slow but still moving forward and the summer reading programs will soon be starting.

County Commissioner Report: Val Val-Shirey reported that there will soon be two positions open on Planning and Zoning. A site for a battery storage unit did not pass through Zoning. The Brond Band situation is still being worked on since no grants have come thru. Commitment from the committee that worked on the Green Energy Applications are still being commended for all their hard work to achieve these new applications. Lastly Val-Shirey would appreciate the support of our residents as she is running for another term for our County Commissioner.
