My letter to you, dated Jan. 26, included the following request:

Please consider adopting the strategic objectives and tactics herein to fix the acquisition process.

Objectives

Strategic objectives to transform the acquisition of weapon systems.

- 1. Hold contractors and DoD program managers accountable for outcomes.
- 2. Tear down NDIA's barrier to entry facing non-traditional defense contractors.
- 3. Eliminate regulations that increase costs and enable false reporting.
- 4. Institutionalize digital engineering.

I am pleased that Sec. 3(a) of Pres. Trump's Executive Order dated April 9, "Reducing Anti-Competitive Regulatory Barriers," requires DoD to complete a review of all regulations subject to their rulemaking authority and identify those that"

- (ii) create unnecessary barriers to entry for new market participants:
- (v) unnecessarily burden the agency's procurement processes, thereby limiting companies' ability to compete for procurements;

A similar request, in a letter to your predecessor, Hon. Kathleen Hicks, Subj. DoD Acquisition Reform Needs and Recommendations, dated Feb. 9, 2021, included the following excerpt:

Solution is to implement the PMIAA at DoD including replacing EIA-748 with a standard that is in accordance with ANSI-accepted P/PM standards, as prescribed in the white paper, the tutorial, and in an email to Ellen Lord.



Ms. Hicks and Ms. Lord did nothing about it. Thanks for not kicking the ball down the road. Instead, you got the ball rolling. Please work with the FTC and OMB to rescind the DFARS Earned Value Management System clause.
