

## TOWN COUNCIL MEETING October 2, 2017

The Town Council met October 2, 2017 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:00p.m. Council Member Crumpton gave the invocation.

Council Member Littleton moved to approve the minutes from September 18, 2017 as presented. Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman and Crumpton.

Council Member Chapman moved to approve the Planning Commission minutes from September 7, 2017 as presented. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman and Crumpton.

Mayor Hight reported the electrical in the park has been completed with the updates.

Old Business

Mayor Hight reported he has a new quote on the tree removal on Summit St. from Danny Tree Service for \$1500.00 and that includes the cleanup.

Council Member Crumpton moved to approve Danny Tree Service for \$1500.00 for the removal of the tree on Summit St. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman and Crumpton.

Mayor Hight reported the closing Mary St. would cost a lot of money and he had spoken with some of the residents and they didn't want to close it. Mayor stated they are going to put asphalt millings on it.

#### New Business

Mayor Hight reported that the Storm Shelter contract was completed, but he need the approval from the Council to get a loan to cover the Town part. The Town part would be 25% upfront, 50% and 25% at completion. He stated FEMA would reimburse the Town but it may take a little longer.

Council Member Littleton moved to approve the Mayor to get a loan for the Storm Shelter. Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman and Crumpton.

#### Report from Department Heads

Terry Jackson reported and gave the Council a copy of the bids for Trucks and Mini X.

Council Member Littleton moved to approve bids from Stokes on 3 Dodge trucks for \$96,518.00, and Takeuchi Cap Mini X for \$41,780.00. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman and Crumpton.

Terry Jackson reported on some leaks they have had.

Mayor Hight asked about Jones St. Terry reported they have completed and should be coming back to pick up the signs.

Terry also stated the garbage truck is slow, but should get better.

Town Clerk Crystal Smith reported she got Rux Carter Insurance to give the Town a quote on the Town Insurance. She stated Mayor Hight and herself had met with Rux and went over everything and the savings would be around \$9000.00. Mayor Hight suggested the Town go with Rux Carter Insurance.

Council Member Crumpton moved to approve Rux Carter Insurance. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman and Crumpton.

Council Member Chapman moved to approve the bills, transfer funds and financial statement. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, and Crumpton.

There being no further business to come before the council, Council Member Chapman moved to adjourn. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, and Crumpton.
