Lake Forest Yacht Club Dock Rental policy and regulations:

1. **No boat may be placed in a slip or launched at LFYC until all financial obligations have been met.**
2. Only above registered boat in the name of lessee are eligible for mooring at the leased slip. A COPY OF THE BOAT REGISTRATION MUST ACCOMPANY THIS APPLICATION.
3. Boats docked without proper identification may be removed at the discretion of the Dock Master at the owner's expense.
4. The Lake Forest Yacht Club (LFYC) has the right to remove any visibly damaged, sinking or sunk boats at the owner's expense. LFYC will be held harmless for any original damage(s) or additional damage(s) which may occur with the removal of such boat.
5. No winter storage will be permitted. Boats must be removed by December 1<sup>st</sup>, 2019 or the LFYC may remove it at owner's expense.
6. No boats are to be left on LFYC property after removal from water.
7. Carpeting and / or tires will not be permitted on ANY docks.
8. Two vehicle parking permits and a security gate key will be issued to renter. No gate key maybe lent to or used by anyone but the Lessee of the slip, Loss of slip will occur for violations of this policy with no refund.
9. Lessee is permitted to use only assigned dock slip, parking on property while using boat and access to rest room at beach house (accessed from parking lot only).
10. Lessee is not entitled to LFYC member privileges and restricts any use of property outside of lease permitted use. This includes: LFYC beach, swim area, tennis / basketball courts, recreational field and clubhouse.
11. LFYC does not guarantee dock renter ability to use the lake waters for boating. Lake water level may raise or lower due to environmental conditions or state regulated water level draw down. Dock Renter agrees to hold LFYC harmless for inability to use the dock slip due to water level conditions and is the responsibility of the dock renter to safely moor, operate or remove their vessel in accordance with water level conditions.
12. Violation of any above policies will void Rental Agreement and require immediate vacating of vessel from LFYC property and return of parking permits and gate tags.

*I will abide by all the Club Dock lease regulations as detailed above. I agree to hold the Lake Forest Yacht Club (LFYC) free from any and all liability including injury to person(s) or property and / or loss in connection with the use of the premises leased. I also agree to reimburse the LFYC for any damage to the leased premises arising from my use of the premises. I have read the above Club Lease Regulations and warrant by my signature below that I understand and am in full compliance with these regulations.*
