Quarterly Investment Report - June 30, 2024

Treasurer Getty presented the fourth quarter investment report. In summary, the LTTO's portfolio continues to perform well, outperforming its benchmark (Bank of America Merrill Lynch 1-10 Year Treasury & Agency Index) with 30.66% higher returns (LTTO: 1.186% vs. BOA ML 1-10 Index: 0.895%) in the fourth quarter of FY2024. Treasurer Getty informed the Trustees that the interest distribution was \$3 million to member districts for the quarter, which is \$450,000 higher than the fourth quarter FY2023 interest earnings/distribution.
