## Maine Ground Water Association Annual Meeting In Person at The Best Western Plus in Waterville February 6, 2023

The Annual Meeting was called to order by President Jesse Goodwin of Goodwin Well & Water at 1:35 P.M. with the following present, Patrick Smith & Susan Smith of Hansen's Well Drilling, Inc., James L. Minutes: A motion made by Scott Abbotts and seconded by Frank Hegarty to approve the minutes from the January 24, 2022 Annual Meeting and there was no minutes/voting from the April 8, 2022 General Meeting presented by Tim Doyle of Maine Motor Transport Association on How to Register a Drill Rig that was held at Goodwin Well & Water was unanimously approved.

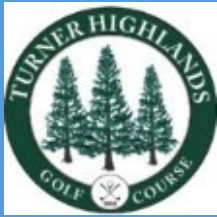

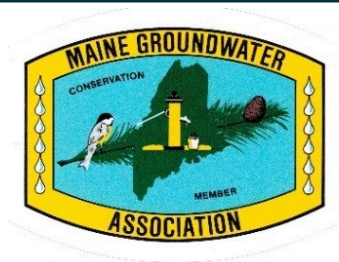
