Florida roads chief praises clearing of Hurricane Irma debris



Florida's transportation secretary is giving his agency a passing mark for debris removal after Hurricane Irma. But with debris still along some roads, particularly in pockets of the Florida Keys, Department of Transportation Secretary Michael

Dew said officials will look at how they can improve before the next storm. "I think we did an effective job, but I think we can always do better," he said Thursday during a meeting of the House Select Committee on Hurricane Response and Preparedness.

The pace and cost of debris collection has been a point of contention in the government's response to Hurricane Irma, which made landfall Sept. 10 in Monroe and Collier counties and barreled up the state. The Department of Transportation has spent \$15 million on debris removal from state highways, with Dew expecting reimbursement from the Federal Emergency Management Agency.

Some of that money related to getting called in to help after local governments complained that debris haulers failed to honor pre-storm contracts as subcontractors went in pursuit of better deals in areas harder hit by the storm. Plan to link Sawgrass Expressway to I-95 rolls ahead



Plans to extend the Sawgrass Expressway in Deerfield Beach to link three of Broward County's main thoroughfares got rolling Wednesday night. Florida Department of

Transportation officials showed a crowd of about 300 people ideas for express lanes to connect Florida's Turnpike, the Sawgrass Expressway and Interstate 95.

Construction could start as early as 2020, said Anson Sonnett, a state Department of Transportation engineer overseeing the project.

A connection was part of the original plans when the Sawgrass Expressway opened in 1986. Several communities supported the link but some residents of Deerfield Beach resisted because it would slice through one of the city's biggest residential developments, Century Village, as well as several business areas. This is the closest the plans have come to becoming a realty in the thirty years of debating the extension. "Express lanes are the only way out of the traffic problems that are piling up on Southwest 10th Street," Sonnett said. Eight traffic lights lie between the end of the Sawgrass and the first on-ramp for I-95. That has led to gridlock during peak hours and an above-average number of crashes at Southwest 10th Street's intersections with Powerline Road and Military Trail, Sonnett said.

"When traffic gets the way it is now on Southwest 10th Street, you can't address it with signal timing," he said. Studies have shown the four-lane, 2½-mile stretch of road between the three highways can no longer handle an estimated 45,000 vehicles each day.

NASA awards construction contracts to small Florida firms

The National Aeronautics and Space Administration has recently awarded Multiple Award Construction Contract Two (MACC-II) contracts to 20 small businesses and four large firms across the United States, six of which are from Florida.

Construction contracts included in the regionalized Indefinite Delivery/Indefinite Quantity contract vehicle are awarded in six categories: woman-owned small business, historically underutilized business zone, service-disabled veteran-owned small business, 8(A) Business Development Program, small business, and full and open unrestricted awards. The contracts, which are anticipated to cost not more than \$3 billion over an eight-year ordering period, are part of the U.S. Small Business

Administration's efforts to help small, disadvantaged firms to compete in the construction market.

Florida firms that have been awarded contracts are ELCI Construction Group Inc. from North Miami in



women-owned small business awards; ESA South Inc. from Cantonment, Advon Corporation from Tallahassee and Firewatch Contracting of FL LLC from Tampa in service-disabled veteranowned awards; and Silver Mountain Construction from Jacksonville and CCI Energy and Construction Services from Shalimar in 8(A) awards.


