### **COLLECTIONS**

Due to the current health issues, your Association Board of Directors provided an additional thirty (30) day period to Owners to bring their assessment account current and even sent out a courtesy statement. But is your assessment account still delinquent? You have still NOT paid? Then on May 1st, the collection policy process will begin and, you can expect to receive a Notice of Delinquent Assessment (NODA) adding \$50 to your delinquent account.

In a letter on March 18, 2020 the Nevada Real Estate Division, Office of the Ombudsman's message called for Associations to implement a moratorium for liens and nonjudicial foreclosures **for those who are being impacted due to the COVID-19 pandemic.** Shortly thereafter, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law by the President on Friday, March 27, 2020.

In support of this effort your Association Board of Directors, while fulfilling their fiduciary duty and acting in the best interest of the Association, implemented protections and shall not initiate a foreclosure of a lien by sale during the period on which CARES began and ends on the date that is ninety (90) days after the date on which CARES ends. Therefore, if you are an Owner of Record and have filed a claim using the CLAIMANT SELF SERVICE (CSS), you may be entitled to the protections. Owners still receiving their pay are not considered unemployed and are not eligible for benefits. Owners still employed, but the regular hours of work have been reduced, depending on the number of hours that have been reduced and the amount of earning for the week, the Owner may be eligible. If you still are receiving more than \$469 gross earnings per week, you will not be eligible. The protections form will be included in the NODA mailing.
