

**Rock River Thresheree Inc.**  
**Winter Camping Unit Storage Contract**

Rock River Thresheree (known hereafter as RRT) views winter storage as a convenience for members who work on the grounds during the summer months and have had their camping unit(s) on the grounds for two months or more. It is intended for a maximum of 30 board approved camping units to be stored on the grounds from the first weekend of November to the first weekend in May. You must initial each line that you have read and understand the rules.

1. All Members that wish to store their camping unit on the RRT ground must complete an application yearly. Applications must be completed and turned in with \$50.00 storage fee by September 30th. Board Approval will be done at the October Board of Directors Meeting. **Initials** \_\_\_\_\_
2. Any unit not approved must be removed from the RRT grounds prior to October 31st. **Initials** \_\_\_\_\_
3. Once board approved; camping unit(s) are to be moved to the board approved area. Shown on the attached map. All campers must be parked perpendicular to the tree lines, maintaining a distance of 10 to 15 feet from the next camper. All propane tanks and batteries must be removed and taken home. Along with camping unit(s) picnic tables and fire rings may be stored in the tree line behind your camping unit(s). Firewood may remain on your campsite but must be maintained in a neat and tidy pile. **Initials** \_\_\_\_\_
4. Winter Storage on the RRT Ground is restricted to camping unit(s), picnic tables and fire rings only. All personal transportation devices such as golf carts, ATV's, UTV's and similar devices must be removed from the grounds by the first weekend in November. **Initials** \_\_\_\_\_
5. Your campsite must be cleaned up and clear of all auxiliary structures, picnic tables and fire rings. Firewood is the only thing that may remain on your campsite. **Initials** \_\_\_\_\_
6. Class "A" Motorhomes are not eligible to be stored on the RRT grounds. **Initials** \_\_\_\_\_
7. All units must be moved into storage by the first weekend in November and MUST be moved to a campsite no later than June 1st. **Initials** \_\_\_\_\_
8. Any noncompliant member having a camping unit(s) remaining on the grounds after winter storage deadline will have their storage privileges revoked permanently. Noncompliant camping unit(s) will be removed to the member's address on file with the RRT Secretary at the MEMBER'S EXPENSE. **Initials** \_\_\_\_\_
9. All decisions made by the RRT Board of Directors on Camper Storage are indisputable and final.

10. RRT is NOT responsible for any damage or theft to camping units or other stored property during any portion of the storage period. **Initials** \_\_\_\_\_
11. The RRT Board of Directors has the final decision on all Winter Camper Storage Matters. The directors may amend, delete or add to any of the rules mentioned above. In the event of any change(s) made by the Board of Directors, notification will be mailed to all approved winter camper storage members that said change(s) have been enacted. **Initials** \_\_\_\_\_
