Vice Chairman Rainey moved to discuss the FY 2026 Budget: seconded by Commissioner Shephard. The Commission approved to discuss the FY 2026 Budget.

DISCUSSION:

Vice Chairman Rainey stated he has reviewed the FY 2025-2026 Budget and he would like to see the following decrease and increase:

- Education and Travel decreased to \$5,000.
- City's fees and services increased 10%.

Commissioner Shephard stated that she does not agree with Vice Chairman Rainey regarding decreasing Education and Travel. Commissioner Shephard stated that she is GMA District 8 President and she must travel to different cities for meetings and training. She also sits on the GMA Board of Directors and that requires traveling to attend different meetings and training.

There was a brief discussion regarding the maintenance of the Holding Pond.

Suggestions made for maintenance:

1. Public Works can maintain them with the proper equipment.
2. They can be contracted out.
3. They can be maintained with a remote system.

Chairman Deriso stated that the Commission need to review the following:

- The Agreement with IDC, which is \$96,000 a year, this will save the City some money.
- Public Works – Lawn Care Services and Holding Ponds. Compare maintenance of the Holding Ponds – options are:
 1. Contract to a qualified Contractor.
 2. City maintain with purchase of an Excavator.
 3. Remote System cleaning the Holding Ponds.

The Commission requested for the following items to be on the next City Commission Meeting Agenda for them to review:

- Fines and Service Fees
- All Contracts
