1. There is hereby established a handicap parking zone on the south side of Park Avenue, Cohocton, New York said handicap parking zone delineated as follows: Commencing 102.8 feet easterly from the intersection of Park Avenue and Erie Street thence continuing easterly on Park Avenue 43 feet on the south side from the traveled portion of the street to the lands occupied by The Cohocton Central School.
2. Parking or standing shall be prohibited in said zone unless said vehicle shall have visibly displayed on said vehicle the appropriate sticker, sign or other designation, as may from time to time be issued by the Department of Motor Vehicles, indicating the owner or operator of said vehicle to be handicapped.
3. A violation of this local law shall be punishable as follows:
 - a) a fine of \$5.00 for the first offense;
 - b) a fine of \$10.00 for the second offense;
 - c) a fine of \$25.00 for each additional offense
4. This local law shall take effect upon filing with the Secretary of State.

- 1) There is hereby established within the Village of Cohocton, New York, a limited handicapped parking zone on the north side of Maple Avenue, Cohocton, New York, defined as follows: COMMENCING at a point 169 feet westerly from the intersection of the extension of the northerly curb line of Maple Avenue with the intersection of NYS Route 371, said point marking the easterly terminus of said limited handicapped parking zone; thence continuing westerly along the north curb line of Maple Avenue, 26 feet to a point, said point marking the westerly terminus of said limited handicapped parking zone.
- 2) Parking or standing shall be prohibited in said handicapped parking zone at all times unless the vehicle shall be registered pursuant to Section 404-a of the Vehicle and Traffic Law or possesses and visibly displays a special vehicle identification parking permit issued pursuant to Section 1203-a of the Vehicle and Traffic Law.
- 3) A violation of this local law shall be considered a traffic infraction as that term is defined in Section 1 800 of the Vehicle and Traffic Law.
- 4) A violation of this local law shall be punishable as a traffic infraction as provided in the Vehicle and Traffic Law, as amended from time to time.
- 5) This local law shall take effect on _____, 1998.
