Bloomfield Police Department Monthly Report for August 2017

This is the monthly report for the Month of August 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, August 6^{th} at approximately 6:10pm officers received a physical abuse of a child complaint. At the conclusion of the investigation a 35-year-old male subject was arrested then confined in the Walworth County Jail. A charge of Child Abuse – Intentionally cause harm has been forwarded to the Walworth County District Attorney's office.

On Tuesday, August 8th at approximately 11:11am officers responded to the 800 block of Primrose Road for a burglary complaint. It was reported that person(s) unknown entered a garage without consent taking several items. This incident remains under investigation.

On Thursday, August 17th at approximately 7:11pm officers responded to a vehicle versus tree hit & run accident in the area of Moss Road and Eau Claire Road. At the conclusion of the investigation a 40-year-old male was arrested and confined in the Walworth County jail. A charge of operating a motor vehicle while intoxicated 3rd offense was forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued citations for failure to notify police of an accident and resisting/obstructing a police officer.

On Saturday, August 19th at approximately 10:06pm officers responded to a personal injury traffic crash which occurred in the area of Hwy H and Spring Creek Road. At the conclusion of the investigation a 67-year-old male was issued a traffic citation for failure to yield right of way from a stop sign.

On Sunday, August 20th at approximately 11:34am officers responded to a report of a domestic disturbance in the 800 block of Violet Road. During the investigation it was determined a 35-year-old male had fled the residence prior to officers arrival. Charges of battery, disorderly conduct, criminal damage to property and felony bail jumping have been forwarded to the Walworth County District Attorney's office. The suspect was ultimately confined in the Walworth County Jail for the aforementioned charges.

On Friday, August 25th at approximately 12:59pm officers responded to the 1000 block of Hwy H for a theft from motor vehicle complaint. Complainant reported that person(s) unknown gained entry through an unlocked door and took items without consent. This incident remains under investigation.

On Friday, August 25th at approximately 6:49pm officers responded to the area of Greenview Road and Clover Road for a possible domestic related incident. At the conclusion of the investigation a 26-year-old female was arrested and confined in the Walworth County Jail. A non-traffic citation for disorderly conducted was issued.

On Sunday, August 26th at approximately 2:06am officers executed a traffic stop in the area of Nippersink Road and Tombeau Road for a traffic offense. At the conclusion of the investigation a 56-year-old male as arrested for operating a motor vehicle while intoxicated. A charge of operating a motor vehicle while

intoxicated 3rd offense has been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued a traffic citation for operating left of center.

On Wednesday, August 30th at approximately 12:14am officers responded to a personal injury traffic crash in the area of Hwy 12 and Hwy U. At the conclusion of the investigation an 18-year-old male was issued traffic citations for unreasonable/imprudent speed, inattentive driving, deviation from designated lane and underage possession of alcohol.

On Thursday, August 31st at approximately 9:40pm officers responded to a report of a high & run traffic crash in the area of Clover Road and N. Lakeshore Drive. At the conclusion of the investigation a 30-year-old male was issued traffic citations for unreasonable/imprudent speed, hit & run property damage and failure to notify police of an accident.

During the month of August 2017 the Bloomfield Police Department responded to 966 calls for service compared to 1037 calls for service during the month of August 2016. During the month of August 2017 the police department affected 108 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 85 arrests during the month of August 2016.
