- **Location/Access:** **Atkinson County GA, Tax Parcel 0063 038 Part of Land Lot 127 of the 7th Land District**, on the south side of paved Cogdell Highway, +-4.7 miles southeast of Pearson GA, or +-5.5 miles southwest-west of Axson GA. There is an improved woods road providing all weather truck access to the back of the property. There is not a gate on the property. - **Description:** **93.622 surveyed acres.** The +-94 acre property consists of +-6 acres of row crop fields; +-45 acres of 2012 and 2015 planted slash pine; +-33 acres of mature natural timber (mostly slash pine); +-3 acres of transmission power line R/W; and the balance is woods road and miscellaneous open. See attached timber maps and timber cruise report. According to NRCS soil maps, the dominant upland soil is Leefield Loamy Sand & Rigdon Sand with a Base Age 50 Site Index of +-84 feet for natural Slash Pine. These primary upland soils are rated "Farmland of Statewide Importance". See attached soil maps and soil reports for more soil information. The property is an excellent timber and hunting property located in one of the best timber markets in the south, and has potential for conversion to agriculture (pasture, blueberries, row crops, orchards, etc.). Great homesites. Old homesite on property, with old tobacco curing barns. Power is on the paved road frontage and transmission line right of way. Flat topography (0% to 2% slopes). Several nice cypress bottoms/drains. Solar farm potential. This property has been in the same family for generations. 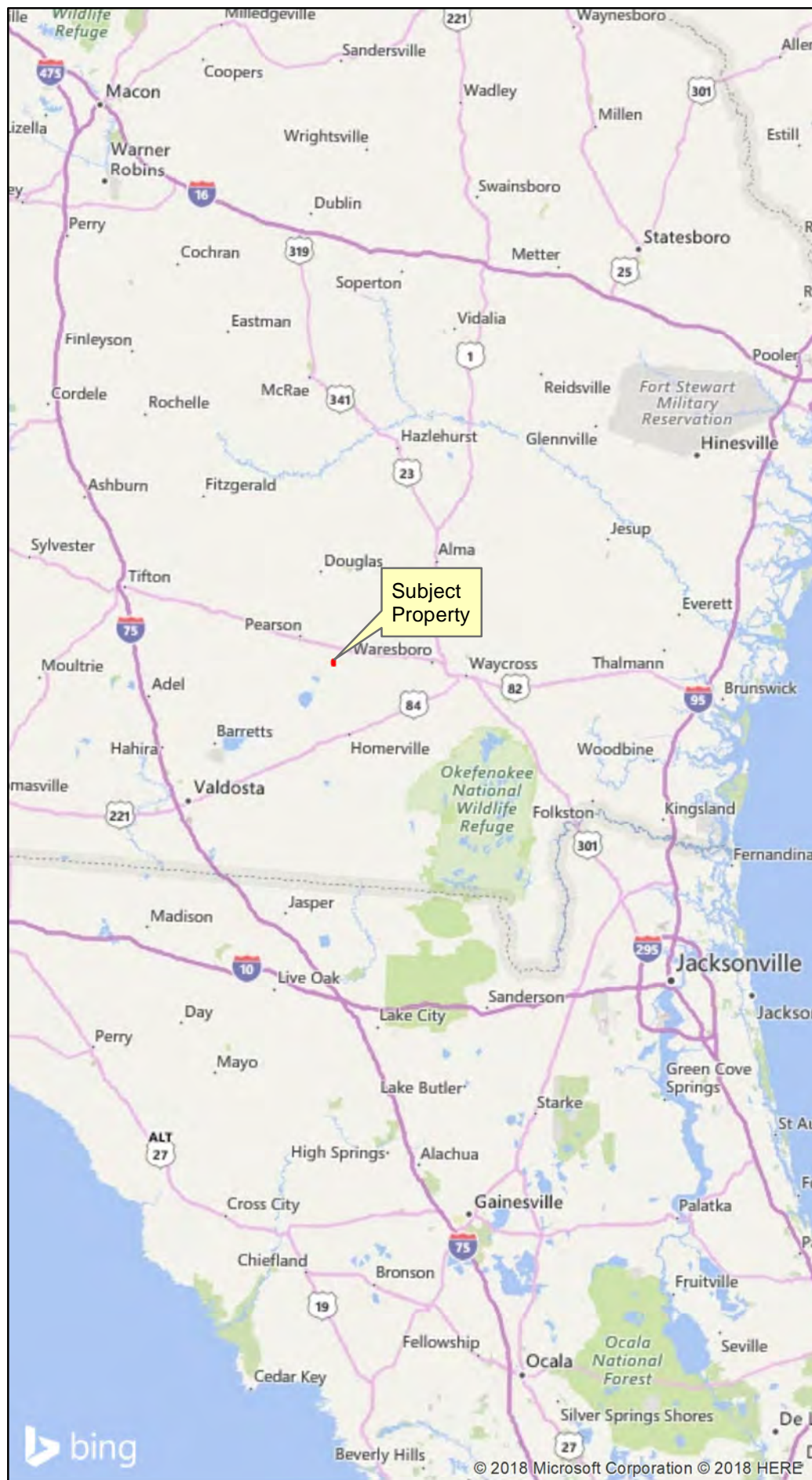

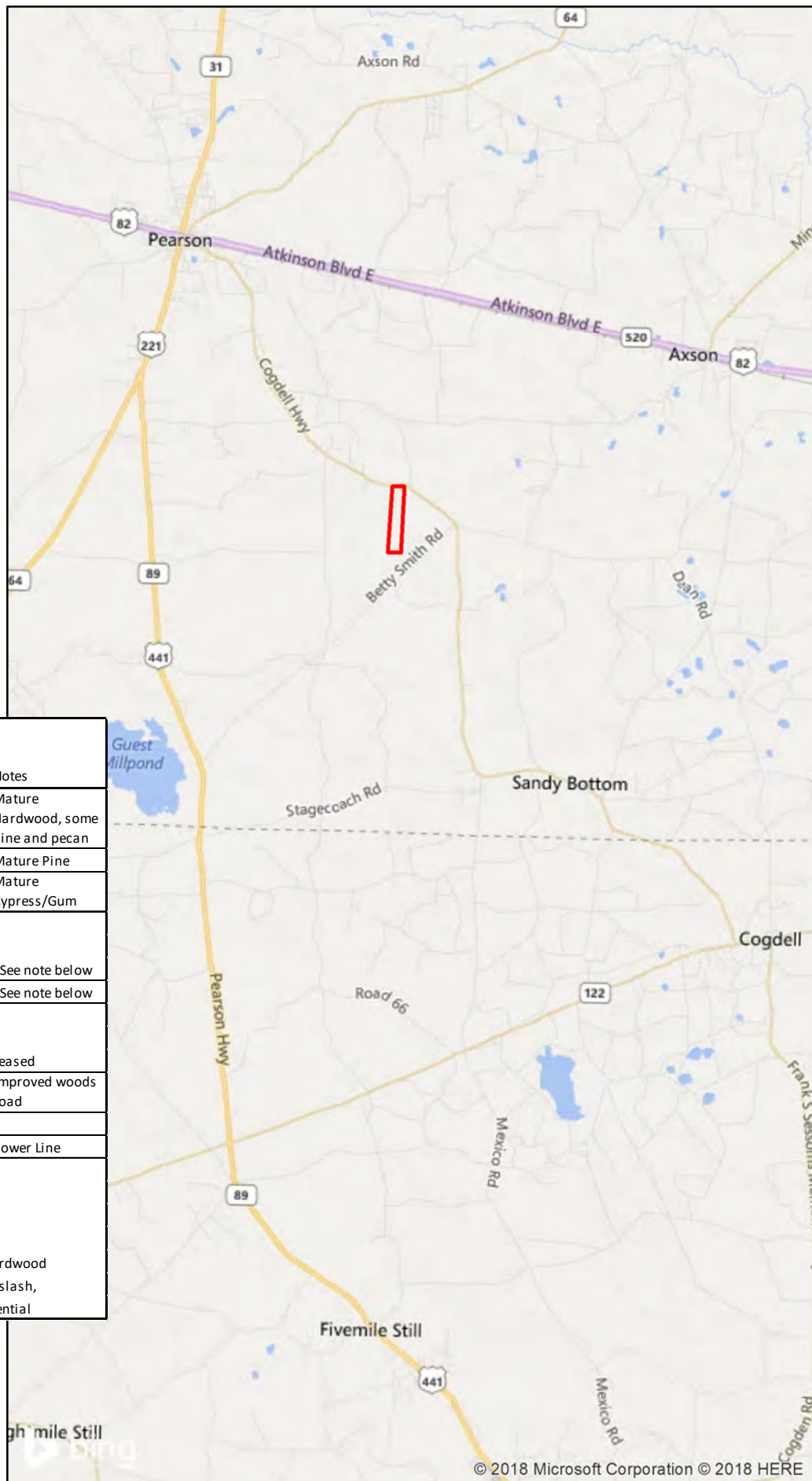
