\_\_\_\_\_ I confirm that I am requesting BGI Associates to place the tracking device on \_\_\_\_\_

\_\_\_\_\_ I am aware that I will be charged \$200 per week or \$600.00 per month rental fee for each GPS device.

\_\_\_\_\_ I agree to a fee of \$500 if the GPS device is lost during the rental period (i.e. removed by vehicle driver, mechanic, other persons or actions). I further understand that if the GPS product is deemed damaged during the rental period, I will be responsible for any labor and/or parts charges to repair the unit up to a maximum fee of \$500.

\_\_\_\_\_ I agree to an installation and removal will be considered billable hours per the retainer agreement.

\_\_\_\_\_ I will continue to be charged \$200.00 per week or \$600 per month, depending on my rental choice above, if the vehicle is not made available for removal of the GPS Device when required.

\_\_\_\_\_ My monthly/weekly rental fees will not be prorated and there will be no partial refund given if I request the GPS device to be removed early.
