
# **TRANSPORTATION**

# Supervisor's Report. (cont'd)

Summer Youth Program- The Town will once again be partnering with the Town of North Elba and the Town of Jay. Families can choose which program would work the best for them. Transportation will not be provided. More info to follow, direct questions to 946-7174.

Water Meters- Well after approximately 15 years the Water Meter project is complete! We are currently training with the new reading and billing system. We plan to be doing a great deal of sample readings throughout the summer to attempt to be sure that when we go online with the meters we are as fair and accurate as possible. After 15 years we feel we can wait eight more months so hopefully we have it right the first time. The remainder of this year will be billed on the current flat rate system. I want to thank Ed Orsi, our Water Superintendent and Darin Forbes for all the hard work in bringing this project to completion.

Town Beach/Beautification- I think most people have heard that the Town was awarded a \$200,000.00 grant for the revitalization of our beach area. Due to State budget issues the project may drag out to three years and we need to perform the work in stages, as it is a reimbursement-type grant. We do plan to construct the new bathrooms this year, add a dock, and install new lighting. The future will bring a new pavilion, handicap fishing deck, new parking lot, nature trail, and new fencing. Please bear with us during the construction process.

The town forces will be continuing with sidewalk replacement and plan to further enhance the Bill Carr Memorial at the Library.

We are also going to reinstall the 1980 Olympic sign at the parking area next to the dam. Town forces are constructing the signposts and a roof structure, which will have an Adirondack look. This is a very important part of our history and you can thank Guy Stephenson's questioning where the sign went that made this happen.

*River-* The Local Waterfront Revitalization Plan has finally been completed and adopted by the Town Board. This will assist in protecting our river and also have within it a plan for economic development along the river. This plan is a key to opening the door for funding enhancement projects in the river area. Thanks to my predecessor, Jeanne Ashworth for starting this process.

**Dredging Study**- This is still not complete, but will be this summer. It was held up by the state budget mess, which resulted in the funding being delayed. What we do know is it will be a multimillion dollar process and the Town Board plans to have a public vote to see if the taxpayers want to move forward with the plan.

Whiteface Mt. Highway- The Town has teamed up with ORDA and formed a committee to develop a plan for the restoration of the Whiteface Mt. Veterans Memorial Highway and the facilities on the summit. The committee consists of representatives from Whiteface/ORDA, Adirondack Architectural Heritage, Essex County Planning Office, and myself. The Highway and facilities on the summit are a local, state and national treasure and we are concerned about their condition and are trying to have a plan and seek funding for the restoration of this jewel of the Adirondacks.

Business Grant-The Town, in conjunction with the Essex County Industrial Development Agency, is in the process of applying for a grant for local business improvements. Surveys to all businesses are in the mail. Contact the Supervisor's office with any questions.

# FIRE DISTRICT NEWS

NEWS- Your Fire District Commissioners have had an energy saving audit done on the Fire Department building by NYSERTA. This audit was completed to find ways in which we can save money on energy usage in the building. We have already replaced the seals around the overhead doors saving on heat usage and we are looking into more cost effective lighting. Any way we can save money for the district in energy usage will be explored. A copy of the audit is on file with the District Secretary, Shirley Lawrence.

TRAINING – The Fire & Rescue members held a nighttime ice rescue drill below the town dam. Approximately twelve members attended. It was a perfectly cold winter night in which six of our members donned their ice rescue suits and slid into the dark icy waters of the AuSable River to rescue Fire Lt. Chris Kostoss, who ran this drill. Practice makes perfect and everyone performed their rescue tasks quickly and professionally. Each member of the Fire & Rescue must complete eight hours of training each year to remain an active member. Most of our members far surpass the eight-hours mark taking advantage of all training exercises that are offered.

It's time for another update in the never-ending attempt to get our own Cell Tower. The APA had issued a lengthy list of questions to Verizon Wireless and would not consider their application complete until these questions were addressed. I have been advised that the questions have been addressed and hopefully the application will be accepted at the March meeting of the APA. Hey, it's only been over 3 years since I started this endeavor.

#### Dog Owner Information

All dogs over four months of age are required by New York State Law to be licensed. Licensing requires that rabies vaccines be up to date. Please be a responsible dog owner and vaccinate and license your pet. Not licensing your dog could result in a court appearance. Having your pet identified with a dog license or rabies tag is also useful in finding the owner when a pet becomes lost. Licenses may be obtained at the Town Clerk's Office at the Community Center. Wilmington also has a dog control law which can be obtained by contacting the town offices. All dogs are required to be under control of the owner on a leash at all times. For the protection of wildlife NYSDEC will issue violations for dogs running loose.

Thank you for using the new receptacles for dog waste clean up. These are located at the beach and on Route 86.



Our Officers try to offer either Fire or EMS training every month of the year so that all members can keep current on the different techniques used.

SAFETY ISSUES – We must repeatedly remind everyone that if we can't get to you, we can't help you when time may be critical. This last snowstorm was unusually wet and heavy. You must keep your driveway or private road cleared so that emergency vehicles have access. And with Spring right around the corner, please trim all branches and brush from the sides of your driveway so that access is twelve feet wide. There will be a lot of trimming needed from this winter's weighty snow bending trees over.

#### Services

The Library offers many services to our patrons. In addition to book lending, we also have many audio books, and some movies. We have 4 public use computers and we also have wi-fi. With a library card, a patron has access to multiple databases including: auto repair, home maintenance, small engine repair, historical newspapers and many more. We offer access to Learning Express Library, which is a database that offers test preparation, job search and resume writing skills, and college preparation tips. All these services are FREE to our patrons.

The Library is **not** federally funded. We receive some funds from the Town of Wilmington, LPCSD, and AVCSD. We depend on grants and donations to help provide services to our patrons. #### Take a Bite Out of Books



Local school project brings history to life In Spring of 2009, the Wilmington Historical Society initiated a local

children's author project between the Lake Placid Middle School and Kate Messner, author of historical novels for young adults. With local author Kate Messner's historical novels for children, we discovered a perfect connection between literature for youth and local area history. Kate's books include Champlain and the Silent One and Spitfire. After months of planning, on February 19, the Wilmington Historical Society sponsored and funded a program at Lake Placid Middle School with Kate Messner as the presenter. Kate took the students for a "trip back in time" to the American Revolution on Lake Champlain. She read excerpts from her middle grade novel Spitfire set during the Battle of Valcour Island in 1776, signed books, and presented an interactive, multimedia slide show about the real 12-year-old who fought in the battle. Kids were invited to ask questions, handle artifact replicas, taste the food, and try on the clothes of an 18th century sailor. Kate was also able to explain how she uses historical artifacts and historical records to assist in her writing. By all accounts the event was a success, and she has since supplied the WHS with signed copies of her books Spitfire and Champlain. and the Silent One for our library. We were pleased to be able to support both history and literature with this event. In the follow-up, we will continue to offer our services as a local history repository to both students and teachers.

New Picture Rail System. A new picture rail system has been installed in the Wilmington Community Center Room. It was purchased by the Wilmington Historical Society and put in place with the assistance of Bill Skufca, Bob Peters, and Guy Stephenson. The new system will allow the historical society to place photos, artwork, and other relevant displays on the walls with ease and without damage to the walls. In addition, the historical society is also reframing the wildlife painting by June Clow that hangs in the community center.

Adirondack Artifact Night--Fri., June 18 The WHS will sponsor a special area event---"Adirondack Artifact Night" to be held on Friday, June 18<sup>th</sup> at 7pm at the Wilmington Range Hall behind the Little Super Market on Route 86 in Wilmington. Codes Corner: Carbon Monoxide Alarms



regardless of date of construction?

The requirements of this law apply to all new and all existing buildings, without regard to the date of construction of the building, whether or not the building is, or has been, offered for sale.

Did you know that carbon monoxide alarms are now the law for all residences,

"Exception: Compliance with this section is not required where no carbon monoxide source is located within or attached to the structure. However, compliance with this section is required if any carbon monoxide source is subsequently located within or attached to the structure.

"The term 'carbon monoxide source' includes fuel fired appliances, equipment, devices and systems; solid fuel burning appliances, equipment, devices and systems; all other appliances, equipment, devices and systems that may emit carbon monoxide; fireplaces; garages; and all other motor vehicle-related occupancies."
