# CIP Update

- Thank you to those who testified
- CIP passed MCPS Board of Education with changes
- o \$12 million added for warehouse move from North Stonestreet Avenue in Rockville
- Overall budget is \$1.83 billion
- New WJES added to plan
- New high school on Crown Farms will impact many clusters (Gaithersburg, Richard Montgomery, Quince Orchard, and Wootton)
- Will collaborate with City of Gaithersburg to identify possible future elementary school sites
- Remainder of CIP passed
- BOE CIP budget goes to County Executive, who proposes the CIP for the entire county, including MCPS, to the County Council – final passage expected in May 2018
- There will be multiple opportunities for additional input
- County Council testimony will be by cluster rather than area
- The best way to follow CIP developments is the MCPS website. The site will show all building location options which are publicly owned (not those which are currently privately owned)

#### Committee Restructure

- Board of Directors approved committee restructuring plan
- Move some admin to standing statues, eliminated some defunct committees, realigned several subcommittees

#### Blue Book

- Reducing production to save money limiting to 500
- One copy to each school and will carefully evaluate the number given to non-MCCPTA entities

o Delegate, President, Treasurer information of those who opted in available online

#### Financial Review

- November 17 Lisa Betts pled guilty in Montgomery County Circuit Court to embezzling \$39,000 from MCCPTA
- Sentencing will include restitution
- Still investigating the impact on the theft on two local PTAs, one goes back to 2011.
   Police did not include these thefts in their investigation
- o Insurance will reimburse MCCPTA and collect restitution from Betts
- Sentencing scheduled for January 17, 2018. MCCPTA making a victim impact statement. Possible sentence is between six months (can be suspended) to five years. The recommendation was six months suspended. Restitution is suspended during incarceration.

  - o IRS 990 every local must file a 990 or extension by November 15.
  - Charitable Organization Registration due by the end of December. You need the completed 990 to do it.
  - Audit of PTA records conducted at the time the Treasurer changes or at the end of each fiscal year. Should be done by now.
  - MD PTA sends a compliance report to the councils. Will circulate when we receive an accurate report. Call MD PTA for local information.

- Farms data was off by 25%
- If it looks wrong question it
- MCPS did correct the data however, the updated data made FARMS a focus in the study
- Include civic associations sooner rather than later. PTAs should do this or take steps to ensure MCPS is doing it
- Survey interests BEFORE options are on the table
- Meet one-on-one with BOE members
- BOE planning to re-open FAA-RA policy to include school performance as a measure of equity. MCCPTA needs to pay attention to this re-write.
- Option B was chosen, issue was neighbourhood schools vs. equity
