Iowa County Community Foundation Awards Grant to Amana Heritage Society

Good news. The Amana Heritage Society has it received a grant for the Homestead Church interior preservation and repairs project. Safe Haven of Iowa County also received a grant to address drainage and improve the facility on Highway 6 near South Amana.

The Iowa County Community Foundation (ICCF) has announced the distribution of \$144,621.25 to 17 Iowa County nonprofit organizations through its 2025 grant cycle. Grants were awarded to projects improving quality of life and creating long-term impact in Iowa County communities. Grants were presented by program area. Here is the full list of grant awards.

The intent of the program is to encourage and assist in funding the appropriate restoration of historic properties within the Land Use District. ACLU D GRANT ADMINISTRATOR
The Board of Trustees of the Amana Colonies Land Use District approved the hiring of Peter Hoehnle, Homestead, to serve as ACLUD's Paul Bruhn Program administrator.

Hoehnle will be working with ACLUD administrator, Kayleigh Myers, the ACLUD board, as well as the Amana Paul Bruhn oversight committee, to administer the grant award process, help those who apply for grants and to serve as a liaison with the National Park Service and the State Office of Historic Preservation.

The Paul Bruhn Historic Revitalization Grants Program is administered by the National Park Service. Named in honor of the late preservation leader from Vermont, Paul Bruhn, the program is designed to be of assistance to small, rural communities helping them to foster economic development through historic preservation. Historic preservation is a proven economic driver.

Hoehnle's position as Paul Bruhn program administrator will be part time.


The ACLUD was awarded \$748,375 for a program to provide sub grants for significant, at-risk historical properties within the Amana Colonies National Historic Landmark that promise to have a impact upon the community and a sustainable future.

Saving at-risk structures and providing more options for economically viable and sustainable uses for buildings will help point the way for future rehabilitation projects, the ACLUD application noted.

The grants are supported through the Historic Preservation Fund (HPF), which has provided more than \$2 billion in historic preservation grants to states, tribes, local governments, and nonprofit organizations since its inception in 1977. The HPF, which uses revenue from federal offshore oil and gas leases, supports a broad range of preservation projects without spending tax dollars.
