Council reviewed minutes of 04/19/2021, April 2021 list of bills to be paid, April 2021 treasurer's report, Averkamp, Davis, and Ludwig building permits and a liquor license for the Worthington Athletic Association. Langel advised a correction needed to be made on the consent agenda which included changing April 2020 to April 2021. Council and Ludwig thoroughly discussed Ludwig building permit for extension of water and sewer to the new shop on 1<sup>st</sup> Ave. E. and his desire to tap into an existing sewer line and tap off an existing water line. Council agreed to wait until next meeting to further in depth discuss this and advised Manternach to get with Lansing to get estimate to extend water and sewer correctly to the property line. Water/wastewater. Council reviewed pay application #2 from Dave Schmitt Construction. Manternach advised of the \$104,595.43 owed on pay app. #2, \$74,834.96 will be paid from the Road Use Tax fund and \$29,760.46 is eligible to be reimbursed by the State Revolving fund loan we obtained. Manternach advised the change order consisted of adjustment to two manholes which was approved under the SRF loan as well. Motion by Leuchs, seconded by Lueck to approve Change Order for Water Looping Main Project. Ayes: all, carried. Council further discussed heaving sidewalk on Hwy 136 and bridge lips on 136. Motion by Lueck, seconded by Leuchs to table until next meeting until an estimate is obtained. Ayes: all, carried.

Memorial Hall: Burger advised there were a lot of carry-ins with the last wedding and said she will be adding in a section to the contract which charges the renters of the hall a fee for each container which is carried in.

Other Business: Manternach advised she is having issues with the timeclocks in city hall, the public works shop, and memorial hall and has made errors on payroll. Manternach advised cost to repair the three timeclocks averaged \$525 with shipping, labor, and parts and the cost to get three new timeclocks was \$749.
