The United States Trustee (the "US Trustee"), the Chapter 7 Trustee, Jill Ford ("Chapter 7 Trustee"), and Debtor Yomtov Scott Menaged (the "Debtor"), file this Second Stipulated Motion to Extend Deadline for United States Trustee and Chapter 7 Trustee to File Complaints Objecting to Discharge Under 11 U.S.C. § 727 (the "Motion") and respectfully shows the following:

## MEMORANDUM OF POINTS AND AUTHORITIES

- 1. The Debtor filed his voluntary Chapter 7 bankruptcy petition in this case on April 20, 2016.
  - 2. The case was dismissed and then reinstated by order dated June 2, 2016. See Docket #37.
- 3. On August 26, 2016, the Debtor appeared and testified at the meeting of creditors pursuant to 11 U.S.C. § 341. Based on that testimony, as well as information obtained from other sources, the US Trustee and Chapter 7 Trustee believe this case presents potential dischargeability issues under 11 U.S.C. § 727.
- 4. The current deadline for the US Trustee and Chapter 7 Trustee to file complaints objecting to discharge under 11 U.S.C. § 727 is November 15, 2016.
- 5. The US Trustee received documents and to took the Debtor's examination pursuant to Fed. R. Bankr. P. 2004 on November 3, 2016. Counsel for the US Trustee has conferred with the Debtor's counsel regarding the document production and examination. The parties believe that in order to allow the parties sufficient time to resolve a discovery dispute that has arisen between them, the current deadline for the US Trustee and Chapter 7 Trustee to file complaints objecting to discharge under 11 U.S.C. § 727 should be extended until December 15, 2016.
- 6. Accordingly, the parties agreed to the filing of this Motion requesting that the Court issue a stipulated order granting this Motion that is being uploaded concurrently with this filing and that extends the deadline for the US Trustee and Chapter 7 Trustee *only* to file complaints objecting to discharge under 11 U.S.C. § 727 until December 15, 2016.
