Please be advised that I write this letter on behalf of my firm, Mr. Todd Weglarz and me. Judge Wendy Baxter has joined in signing this letter as it has come to our attention that you have continued to perpetrate libelous and slanderous statements against all of us. Plain and simple, that means that you are either publishing untrue, derogatory and highly inflammatory statements in writing and/or otherwise doing so by oral representation.
