

MUNICIPAL ORDER FIRE BAN Effective May 30, 2019 Until Further Notice

All open fires in B-Say-Tah are prohibited, however CSA approved self contained (propane/natural gas) portable gas heating devices, fire pits, barbeques, pressurized stoves, and charcoal briquettes will be permitted for cooking and heating purposes.

MUNICIPAL ORDER FIRE BAN

BYLAW NO. 46 A BYLAW RESPECTING FIRE RESTRICTION

WHEREAS

1.In the opinion of the Municipality Resort Village of B-Say-Tah, and extreme fire hazard condition exists within the municipality;

THEREFORE, Dave Sabrish being Fire Chief and Richelle Haanstra being the Administrator appointed pursuant to section 15 of Bylaw No. 46, do hereby order, pursuant to section 14 of that Bylaw that:

i)No person shall light, or start or allow or cause to be lighted, ignited or started a fire of any kind whatsoever in the open air.

ii)All burning permits, if any, issued for the burning of material within the municipality are hereby suspended effective the date of this order.

iii) The lighting or discharge of fireworks is strictly prohibited.

This fire ban includes and does apply to all lands located within the Municipality of Resort Village of B-Say-Tah.

This order takes effect May 30th, 2019 and will continue to be in effect until further notification from the Municipality.

If it is missed it will be collected with the waste collection on Tuesdays. Waste Collection is every Tuesday starting at 7am sharp.

FIRE CHARGES FOR CALL OUTS

Reminder that things are still quite dry out, use precaution and common sense etc. As per our bylaws for fire call outs the Village will cover the first \$1000.00 of the call out should you require the fire department's assistance. You will be responsible for the remainder of the costs if any. A \$600 minimum fee for fire dept. to attend for first hour plus a \$200 fee per every hour after that. Refer to our bylaws posted on the Village website, keep your insurance company informed.

Please obtain all necessary permits prior to any development/building or demolition within the Village. If you are unsure if you need one, please inquire at the office.


