







VOTE BY MAIL

Vote-by-Mail refers to voting a ballot received by mail or picked up during the designated days for a voter instead of going to the polls to vote during early voting or election day. Any registered voter can vote by mail. You can request a Vote-by-Mail ballot for a specific election or for all elections through December 2024. After the 2024 General Election, you will need to make the request again.


If you are presently registered to vote in Broward County, you may request a Vote-by-Mail ballot online (see link below). You may also request a ballot by email, fax, phone or mail.

Voters who wish to receive a Vote-by-Mail ballot for 2023 through 2024 elections are required to complete a new Vote-by-Mail ballot request.

The name of this organization shall be the Coconut Creek-Margate Democratic Club.


ARTICLE II: OBJECT AND PURPOSE


The object of this organization shall be to:
