### **Recent & Ongoing Activities**

- March 19: Rally for the Fund: rally in Annapolis encouraged the General Assembly to support <u>HB</u>
   1687 or SB 1122 so that state Casino revenues will finally be used to boost State-wide education funding.
- Maryland General Assembly currently in session, considering dozen of education-related bill including
  - o <u>HB 679</u> to overturn the annual school end-date set by the Governor by executive order in August 2016;

- o <u>HB 1415</u>, the so-called Kirwan Commission bill, to establish early literacy programs, create Learning in Extended Academic Programs (LEAP) grants for schools in which at least 90% of students qualify for federal free/reduced priced meals, expand eligibility requirements for the Teaching Fellows for Maryland scholarship program; create grants for more schools to build innovative a Career and Technology Education programs; and extend the final report date for the Commission on Innovation and Excellence in Education.
- SB 1122 was approved by the Senate 3/19 on a vote of 47-0 to put to a general election vote amending State Constitution to lock in state casino revenues to supplement (not supplant) Education dollars.
- County Executive endorsed the Board of Education's <u>operating budget proposal</u>. The recommended \$2.59B budget for FY 2019 is a \$72.96 million (2.9 percent) increase over FY 2018. Most of this increase will be used to provide the same level of services to our growing number of students, ongoing salaries and benefits, and increasing operational costs, but it also includes \$16.12 million to expand and implement our key bodies of work. This includes:
  - o Introducing new career readiness pathways, including Aviation and Aerospace; Cybersecurity; Fire Safety and Rescue; Law Enforcement and Leadership; and more
  - o Adding more two-way elementary language immersion programs
  - o Expanding programs in Computer Science, Coding and Robotics
  - o Implementing extended year programs at two elementary schools beginning July 2019
  - Launching a Recovery Education program
  - Expanding the College Tracks and Achieving Collegiate Excellence & Success (ACES) programs
  - o Expanding Middle and Early College program
