- I. Secretary Hagstrom called the meeting to order at 5 pm.

- III. Nominations for Board Seats ~

This being the organizational meeting for fiscal year 2016, the secretary opened the floor for nominations for chairman. Bennetts moved, with a 2nd from Wegner that Art Lyons be placed in nomination for chairman with a unanimous vote requested. The secretary proceeded to ask 2 additional times for further nominations.
