



## BOARDING AGREEMENT

I specifically represent to Wag & Purr Elite Pet Boarding, LLC (Wag & Purr) that I am the legal owner of \_\_\_\_\_.

My pet(s) is/are up to date on all required vaccinations and have not had any communicable illnesses within the past 30 days. I agree if any fleas or ticks are discovered on my pet while at Wag & Purr, Frontline Plus will be applied and I as owner will be responsible for a \$18.00 additional charge. \_\_\_\_\_

**Pick up:** Pets will be released to owners unless otherwise specified. Names of other individuals authorized to pick up my pet have been provided on the Registration Form. \_\_\_\_\_

**Behavior:** My pet is not aggressive. I understand that Wag & Purr does not accept aggressive pets and if my pet exhibits unacceptable behavior, my emergency contact or I may be asked to pick up my pet prior to the end of the boarding term. Aggressive guests may be asked not to return to Wag & Purr. \_\_\_\_\_

**Belongings:** I understand that items left with my pet may not be returned, or if returned may be in poor condition. If a toy is chewed where it is believed to be dangerous to the pet, it will be disposed of. I have brought the following medications, toys, and/or food:

**Medical:** My pet is in good health and vaccinations are up to date.

In the rare event that a guest should require medical attention, Wag and Purr will use the contact information provided to attempt to contact the owner, the owner's veterinarian on record, and/or the emergency contact prior to any treatment.

I understand medical treatment may be provided by a licensed veterinarian other than my own, and authorize Wag & Purr to seek emergency medical care from a licensed veterinarian if deemed necessary for the safety, health and well being of my pet. I am fully responsible for the cost of any such medical treatment. \_\_\_\_\_

**General House Rules:** I agree to abide by all printed house rules and acknowledge I have been given a copy and reviewed the General House Rules. \_\_\_\_\_

**Abandonment:** I agree to pick up my pet(s) by the time they are scheduled to leave. Any guest that is left at Wag & Purr beyond the scheduled pick-up date without contact from me or other authorized individuals listed on the Registration Form will be considered abandoned upon the 7<sup>th</sup> day after mailing of certified letter, return receipt requested. I understand that if I abandon my pet at Wag & Purr, by default, Wag & Purr becomes the legal owner of the pet. Wag & Purr has the right to place the pet with a new owner or relinquish to a shelter of their choice. I understand that if I abandon my pet at Wag & Purr, I may be unable to retrieve possession of my pet and have no recourse against Wag & Purr. \_\_\_\_\_

**Assumption of Risk:** Owner acknowledges and is aware that the representatives of Wag & Purr are not veterinarians and are not expected to diagnose or detect illnesses in guests. In addition, owner acknowledges and is aware that vaccines do not protect against all communicable illnesses that may affect a guest. Owner agrees they are assuming all risk of illness and/or injury, and will be charged for emergency services if it is believed to be necessary for the health and well being of guests.
