RESOLUTION NO. 25-12-04

WHEREAS, this Resolution was offered by Commissioner Sharon Hawn and seconded by Commissioner John L. Staud adopted after an affirmative vote of a proper quorum of the Board of Commissioners at a meeting which was called and held after all required legal notice and pursuant to all procedural requirements, laws of this State, and after a public comment period was afforded prior to action being taken, which Resolution provides as follows:

IT IS RESOLVED, the intent of the East Baton Rouge Fire District 6 Fire Prevention Bureau is to prescribe regulations consistent with the provisions provided in Louisiana R.S. 40:1563 as well as regulations consistent with nationally recognized good practice for safeguarding to a reasonable degree of life and property from the hazards of fire and explosion arising from the storage, handling, and use of hazardous substances, materials and devices, and from conditions hazardous to life and property in the use of occupancy of building or premises. The most current State of Louisiana adopted version of the fire life safety code will be the minimum code which will be utilized by the bureau.

FURTHERMORE, BE IT HEREBY PROCLAIMED The fire prevention bureau will be headed by the Chief of the Fire Department or a person designated by the Chief of the Fire Department. The Bureau will be staffed by qualified individuals whose credentials have been reviewed and accepted by the State Fire Marshal.

The bureau will conduct maintenance inspections on behalf of the fire marshal. The Fire Marshal shall have the authority to monitor the performance of the fire prevention bureau in the performance of those functions which would otherwise be performed by the Fire Marshal.
