

City of New Munich City Council Minutes

January 4th, 2016

The City Council of the City of New Munich met in regular session at 6:40 p.m., in the City Hall. Jim Poepping, Pat Nathe, Dan Krueger, Shawn Duevel and Ron Doll were present.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the minutes from December 7th, 2015 were approved.

Steve Uphoff, owner of New Munich Oil Company was present to ask the Council for their approval to change the boundaries of parcel number 68.37927.0035 (120 1st Ave E) and parcel number 68.37927.0030 (100 1st Ave E). On a motion by Pat Nathe, seconded by Dan Krueger and carried to change the boundaries were approved.

Fire Chief, Allen Fiedler was present and informed the Council of one rescue call last month. He also submitted a few bills that need to be paid. Members of the New Munich Fire Department were present to ask the Council to renovate the City Hall. Worms Lumber had a plan drafted up which estimated costs would be around 325,000. Allen Fiedler is going to research low interest rate loans.

He understands when the authorities get a complaint, but they stay for hours which is not good for business. He is wondering if the City could do something. Mayor Jim will call Stearns County to see what is going on.
