Financial Review	Your PTA/PTSA financial review committee should be in the process of completing their annual review of the records. If that hasn't started, you can reference our financial review template and guideline.	Present financial review at your next general membership meeting. Once accepted by membership, submit in Givebacks.
Officer Contact Roster	Free State PTA bylaws require that an updated officer contact roster be submitted. If that hasn't occurred, please complete immediately.	Submit in Givebacks.
IRS 990	Your PTA/PTSA's annual 990, 990-N, or 990-EZ can be filed anytime between 1 July 2025 and 15 November 2025 with IRS.gov. The type of 990 form will depend on how much your PTA/PTSA received in the last FY. We recommend completing before 15 November 2025.	Submit your accepted 990 submission in Givebacks.
Maryland Charitable Renewal	Your PTA/PTSA's annual Maryland Charitable Renewal can be filed anytime between 1 July 2025 and 15 November 2025 with Maryland One Stop.	Submit your MD Charitable Renewal acceptance in Givebacks.
Pay Dues	Submit dues monthly to Free State PTA and Harford County Council of PTA.	You can pay via check or through Givebacks!
Bylaws	Are your Bylaws about to be 3-years old? If they are, it's time for a refresh!	Download the latest local unit template. Determine with your Board if any changes are required.
